The champions Cup is held to **26.+27. November 2005 in Berlin**

1. Time schedule Starting day : 26.11.2005 7:30 – 21:00
 Closing day: 27.11.2005 7:30 – 17:00 (variable)
 Winner ceremony 27.11.2005 1-2 hrs. after the last match (Party with open end)
2. deadline In order to organize the event in time, we would like you to return the Participation form as soon as possible (see enclosure "Participation form")
but not later than 26. October 2005

4. Participation The national champion of each county, best club of countries without a championship and the hosting club. If a team does not participate the 2nd or 3rd team of this country can substitute. The organiser decides on the participation.
5. Men / women Men and women play separate cups. Women are allowed to play in men teams.
6. Minimum number of women or men teams to carry out the cups
 Four teams of women. If there are less, we do not promote the women Cup.
 Four teams of men. If there are less, we do not promote the men Cup.
7. The Champions Cup will not be held,
 when less than four teams are registered. We only payback registration fees. All other cost are on own risk.
8. Rules The international UWR rules of C.M.A.S. (1.9.2000) and the additional rules of invitation.
9. Play mode Will be published when all teams are registered.
10. Play time The play time depends on the number of teams. We play in real time. On play interruptions the clock will be not stopped. Will be published when all teams are registered.

11. Result of match Every match has to find a winning team. If some match is open after time, alternating penalties have to find a winning team. The team with one goal more is the winner. At penalty, players can be only one time goalscorer and only one time goalkeeper.
12. Fiberfins are allowed, when the fiberfins are save AND the referee think so too. It is a referees decision on tournaments day.
13. Jury of tournament: 1 referee (named by the referees)
2 team representatives (named by the team captains)
14. Referee Every team has to provide one referee at minimum. (A or international experience preferred). Teams without a referee have to pay 70,- €. All other referee appointments will be done by BUR Berlin e.V. in arrangement with Ulli Scheuermann (chief referee of tournament).
15. Protest Written protest must be submitted in to the jury of the tournament within 30 minutes after the game has ended. Protest fee is 50,-€
